

# Top 10 Things to Know About ABRHS Project Graduation



1. Project Graduation is an all-night, substance-free event exclusively for Acton-Boxborough Seniors held at Acton-Boxborough Regional High School (ABRHS). The goal is to keep our teens safe and include the entire graduating class in one final celebration!
2. Project Graduation 2018 ("PG18") is on graduation night, Friday, June 1st-2nd from 10 PM–5 AM. Check-in is between 9:30–11 PM in the ABRHS Auditorium, doors open at 10 PM.
3. PG18 tickets are \$20 per person and will be on sale 10 AM–1:30 PM on April 24, 25, 26, 27 alongside Prom ticket sales. Tickets will also be sold at the ABRHS Auditorium door on June 1st.
4. What's in store? Food, games, karaoke, casino, hair & nails, crafts, basketball, dodgeball tournament, temporary tattoos, caricatures, a mechanical bull and more! Also tons of prizes and scholarships! We will end the evening with a game show and hypnotist!
5. Graduates, regardless of age, may NOT leave Project Graduation early without permission and transportation by a parent/guardian. We ask that all parents/guardians be available by phone from 10 PM–5 AM in case of emergency.
6. While Project Graduation is not a school-sponsored event, school rules still apply. Graduates are expected to be respectful to volunteers staffing the event, to their fellow graduates, and to school property.
7. **IMPORTANT:** A signed waiver is required to ride the mechanical bull. Students 18+ may sign it themselves, otherwise it must be signed by a parent/guardian (complete waiver on reverse side and bring to event).
8. All you need to bring is an ID, \$20 if you haven't pre-paid, signed waiver for the mechanical bull, your phone, a sweatshirt because it's cold in the school, and your yearbook. Graduates must check their bags and belongings upon arrival. Access to belongings is available throughout the night, supervised by event volunteers.
9. No outside food or drink permitted, plenty will be provided.
10. The general public is invited to come see the transformed halls of the high school from 9–10 PM on June 1st.

**PARTICIPANT AGREEMENT  
RELEASE OF LIABILITY, WAIVER OF CLAIMS  
EXPRESS ASSUMPTION OF RISK AND INDEMNITY**

In consideration of gaining access to Paul Rents, Inc. and engaging the services of Paul Rents Inc. at the Location, on behalf of myself, my spouse, my children, my parents, my heirs, assigns personal representatives, estate, and insurers, I hereby release, indemnify, hold harmless, and discharge Paul Rents Inc., its agents, owners, officers, affiliates, volunteers, participants, employees, insurers and all other persons or entities acting in any capacity on their behalf (herein after collectively referred to as "Paul Rents Inc."), from any and all claims, demands, or causes of action in any way, either directly or indirectly, based upon, arising out of, connected to, or involving my participation in this bull riding activity or use of Paul Rents Inc. Equipment as follows:

1. \_\_\_\_ (Initial Here) I acknowledge that my participation in riding the bull entails known and unanticipated risks that could result in physical or emotional injury including, but not limited to, broken bones, sprained or torn ligaments, paralysis, death, or other bodily injury or property damage to myself, to property or to third parties. I agree and represent that I do not have, or ever have had back, neck, joint or bone injury. I further represent that I am not pregnant, intoxicated, or under the influence of drugs, nor do I have any existing medical or health condition(s). I understand that such risks simply cannot be eliminated without jeopardizing the essential qualities of the activity. I expressly agree and promise to accept and assume all of the risks existing in this activity. My participation in this activity is purely voluntary and I elect to participate in spite of the risks.

2. \_\_\_\_ (Initial Here) I expressly acknowledge, agree and promise to accept and assume all of the risks existing in this activity. Furthermore, I recognize and acknowledge Paul Rents Inc. employees have difficult jobs to perform. They seek safety, but they are not infallible. They might be unaware of a participant's fitness or abilities. They may give incomplete warnings or instructions, and the equipment being used might malfunction. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.

3. \_\_\_\_ (Initial Here) If I am injured, I acknowledge that I may require medical assistance, which I acknowledge will be at my own expense or the expense of my personal insurer(s). I hereby represent and affirm that I have adequate and appropriate insurance to provide coverage for such medical expense. I UNDERSTAND AND AGREE THAT Paul Rents Inc. WILL NOT PAY FOR ANY COST OR EXPENSE INCURRED BY ME IF I AM INJURED.

4. \_\_\_\_ (Initial Here) I hereby voluntarily release, forever discharge, and agree to defend, indemnify, and hold harmless Paul Rents, Inc. from any all claims, demands, or causes of action, which are in any way connected with my participation in Paul Rents Inc. activities and/or my use of Paul Rents Inc. equipment or facilities including, but not limited to, any such claims based upon damages caused or alleged to have been caused in whole or in part by the negligent acts or omissions of Paul Rents Inc. warnings or instructions, and the equipment being used might malfunction. My participation in this activity is purely voluntary, and I elect to participate in spite of the risks

5. \_\_\_\_ (Initial Here) Should Paul Rents Inc. or anyone acting on their behalf be required to incur attorney's fees and costs to enforce this Agreement, I agree to indemnify and hold them harmless for all such fees and costs.

6. \_\_\_\_ (Initial Here) I certify that I am 18 years of age or older and am physically able to participate in all activities at the Location without aid or assistance, I further certify that I am willing to assume the risks of any medical or physical condition that I may have.

7. \_\_\_\_ (Initial Here) I acknowledge that I have been provided with a copy of the rules, (the "Paul Rents, Inc. Rules") governing my participation in any Paul Rents Inc. activities at the location. I understand that the Paul Rents Inc. Rules have been implemented for the safety of all guests at the Location, including myself. I acknowledge the failure to follow the rules could result in the expulsion from the Location.

8. \_\_\_\_ (Initial Here) I agree that, if any portion of the agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect. If there are any disputes regarding this Agreement, I hereby waive any right I or anyone on my behalf may have to a trial and agree that such dispute shall be brought within one year of the date of this Agreement and will be determined by binding arbitration before one arbitrator by JAMS pursuant to its Comprehensive Arbitration Rules and Procedures. I further agree that the arbitration will take place solely in the state of Paul Rents Inc. and that the substantive law of Paul Rents Inc. shall apply.

9. \_\_\_\_ (Initial Here) I further grant Paul Rents Inc. the right, without reservation or limitation, to photograph, videotape, and/or record me.

By signing this document, I acknowledge that if anyone is hurt or property is damaged during my participation in this activity, I may be found by a court of law to have waived my right to maintain a lawsuit against Paul Rents Inc. and/or the location on the basis of any claim from which I have released them herein. I have had sufficient opportunity to read this entire document. I understand this Agreement and I voluntarily agree to be bound by its terms.
